PRE-BALLOT GENERAL NOTICE OF THE 2020 ANNUAL MEETING OF THE MEMBERS

The Association has selected HOA Elections of California, Inc. to act as the Inspector of Election. HOA Elections' objective is to conduct the election process professionally and as efficiently as possible on your behalf. Pursuant to California Civil Code 5115(b) (effective January 1, 2020), notice of the Annual Meeting of the Members will be held as follows:

When: Tuesday, July 21, 2020

Where: Due to covid19 orders on public gatherings and socially distancing, the annual meeting will be held via video conference. You will be able to ask questions and view the opening of the ballots. Specific information on video conference call-in procedures will be included in your ballot packet which is due to be mailed 30 days prior to the annual meeting. Once you have received your ballot packet, (due to mail June 22, 2020), **please mail your ballots to arrive at the hoa inspector's office no later than the deadline below.**

Time: There will be no open polls the night of the meeting. Should quorum be reached, the meeting will be called to order at approximately 6:00 p.m. to tally the ballots.

Purpose: To elect four (4) Members to the Board of Directors.

Quorum: A majority of the eligible Members entitled to vote for Board Directors (588 out of 1175) must return their Irrevocable Secret Ballots in order for the Annual Election to be held.

Candidates: As of the date of this notice, the following Members have nominated themselves as candidates in the election: Ginny Barnes, Sharon Fornaciari, Wil Gorrie, Elizabeth Kostas, and David Rubin.
